
Do You Know How to File a Formal Sexual Harassment Complaint With Your College or University?

What is a formal complaint?

A formal complaint is the document that a person can file with their Title IX office that describes the sexual harassment incident(s) and asks that the school start a "grievance process." This process looks different from school to school, but overall consists of the filing of the complaint, followed by an investigation of sexual harassment and a hearing to decide the outcome of the case.

Who can file a formal complaint?

If you are a student and experienced sexual harassment, sexual assault, intimate partner or dating violence, or stalking* by a fellow student, faculty member, or member of your school's staff, you can file a formal complaint with your school's Title IX Coordinator. Note: a Title IX Coordinator may file a formal complaint if the school has actual knowledge of a pattern of alleged harassment by either one of its students or an employee, even if the alleged victim is not a student at the school.



*Under Title IX, all of these offenses are considered different types of sexual harassment.

What's the difference between a formal complaint and a report to the Title IX Office?

There are a few big differences between making a "report" and a "formal complaint." Anyone, including a student-survivor, a friend, a professor, or a parent, can report sexual harassment to the Title IX Office. A report just lets the Title IX Office know about the sexual harassment, but does not start a grievance process.

Once the Title IX Office receives a report of sexual harassment, they must tell the survivor about options available for supportive measures (such as changes in class schedules or housing) as well as what a grievance process looks like. A survivor can get supportive measures without filing a formal complaint.

What does a formal complaint look like?

The Department of Education requires that a formal complaint be a document that:

- (1) alleges sexual harassment (including sexual assault, intimate partner violence, or stalking) against a respondent;
- (2) requests that the school investigate the sexual harassment;
- (3) is signed by the survivor (or the Title IX Coordinator); and
- (4) is given to the Title IX Coordinator either in person, by mail, or by email.

Anyone considering filing a formal complaint should review their school's Title IX Policy (sometimes called a Sexual Harassment Policy, Sexual Misconduct Policy, or something similar) to see if their school has additional requirements.

Schools may vary in the amount of detail they require in a formal complaint, whether the signature needs to be done by hand or can be done electronically, or they may provide additional ways to submit a complaint.
